NOTICE OF RACE

1 RULES & HANDICAP SYSTEMS

1.1 The Event will be governed by the rules as defined in The Racing Rules of Sailing (RRS).

2 ELIGIBILITY AND ENTRY

2.1 The Event is open to the Squib class whose owner(s) is a paid up member(s) of GHYC

2.2 The Event is open to the Dragon class whose owner(s) is a paid up member(s) of GHYC

2.3 Helms must be paid up members of GHYC

2.4 Entries are only accepted on successful completion of the Entry Form, which must be delivered, at the noted Registration time, to the GHYC Club house with the Fees, unless paid on-line, required for the Event

2.5 Please check the club web site for Online Payment options

3 FEES

3.1 Required fees are as follows:

3.1.1 Dragons €25

3.1.2 Squibs €15

4 SCHEDULE

4.1 Registration: 14th July 09:30 – 10:00 in the Club House

4.2 Racing Schedule :- The Race will take place on the 14th July



4.2.1 FG for Dragons will be 11:00

4.2.2 FG for Squibs will be 11:10

5 SAILING INSTRUCTIONS

5.1 The GHYC Standard Sailing Instructions(SI's) are already available and the SI Supplement for the event will be available at registration

6 VENUE

6.1 Between Glandore Harbour and Castletownshend Harbour.

7 THE COURSES

7.1 The Sailing Instructions will include details of courses to be sailed by all classes.

8 PENALTY SYSTEM

8.1 For the Dragon & Squib classes, RRS 44.1 is changed so that the Two-Turns Penalty is replaced by One-Turn Penalty, including tack & gybe

9 RADIO COMMUNICATION

9.1 A Working VHF Radio is mandatory for all keel boats in all GHYC racing events.

9.2 Except in an emergency, a boat that is racing shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

9.3 The PRO shall broadcast on Channel 68 general information regarding racing to the fleet including course information that cannot be displayed. Failure to broadcast this information, or to hear it, shall not be grounds for redress. This alters RRS Rule 41.

10 SAFETY REGULATIONS

10.1 Personal Floatation Devices (PFD's)

All competitors shall wear PFDs at all times while afloat, except briefly while changing or adjusting clothing or personal equipment. Flag Y will not be displayed. Wet suits and dry suits are not PFDs. This alters RRS Rule 40

11.1 The Regatta/Race Committee will award Prizes to both as below - Details will be included within the Supplementary SI's
